

#### SILKAR MADENCILİK COOKIE PRIVACY NOTICE

We, Silkar Madencilik Sanayi ve Ticaret Anonim Şirketi ("Silkar Madencilik" or "The Company"), use cookies ("cookie") in order to make the most efficient use of the <a href="https://www.silkarstone.com/">https://www.silkarstone.com/</a> website and to enhance your visitor experience. In the capacity of data controller, we hereby aim to inform you in detail about the cookies we use on our site in order to fulfill our privacy notice obligation under the Personal Data Protection Law No. 6698 ("Law" or "PDPL") and the relevant legislation.

For the cookies we use on our website other than mandatory cookies, explicit user consent is obtained and the right to change their consent at any time is provided. By using the cookie management panel, users can see types of cookies used on our website and can set their preferences by toggling the "on" or "off" options for all cookies other than Mandatory Cookies. Similarly, users can always change their preferences through this panel.

#### What is a Cookie?

Cookies are pieces of text sent to your browser by the website you visit on your computer or mobile device. Data related to your visit; for instance, cookies that help remember the language you prefer or the pages you visit are also used to provide you with a special experience, to improve the services offered on the website, and enhance your experience.

The visitor's browser (Google Chrome, Internet Explorer, etc.) only saves the cookies obtained during the current session on the hard disk in such a way that it takes up the minimum amount of memory space and does not jeopardize the visitor's computer. Therefore, cookies are intended to provide a more useful and personalized experience for a website.

Notwithstanding the foregoing, cookies cannot collect any information stored on your computer or files.

## Cookies Used by Silkar Madencilik

Cookies used on the website for the visitor's purpose of use. These are Mandatory/Technical, Analytical/Performance, Functional, and Targeting/Advertising cookies.

Cookies do not contain any specific personal information and most cookies are deleted from the hard disk after the end of the

browser session. These cookies, called Session Cookies, collect data while the user is browsing.

#### WHICH COOKIES ARE USED ON OUR SITE?

\*Mandatory/Technical Cookies: Mandatory/technical cookies are used to enable the visitor to navigate and use special parts of the site, such as access to secure areas of a page. These cookies are aimed at the proper functioning of the site. For example, it is possible with the use of these cookies to enable the transition between pages in the menu of the website.

\* Analytical/Performance Cookies: These collect information such as the language preferred by the visitor on the website, the frequency and mode of use of the site, and information on how visitors access the website. The purpose of Analytical/Performance cookies is to make the website more useful and to identify the general tendency of visitors. However, these cookies do not contain data that can identify visitors. For example, these cookies may collect information on the average number of minutes visitors spend on certain pages of the website other than the homepage.

\*Targeting/Advertisement Cookies: Targeting/Advertising cookies are cookies that are downloaded by a third party during a usage visit to an application/website. They allow measurement of the efficiency of the advertisements displayed to visitors and a calculation of the number of displays.

## Purposes of and Legal Grounds for Processing Personal Data

Mandatory cookies are used to perform an information society service you have requested (log-in, filling out forms and remembering privacy preferences, counting visitors and measuring traffic on our website). Your personal data collected through these cookies are processed pursuant to clause (c) of paragraph 2 of Article 5 of the PDPL which stipulates, "It is necessary to process personal data belonging to the parties of a contract" or clause (f) thereof which stipulates, "Data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject."

Analytical/Performance Cookies These cookies are frequently used to improve our website and are also used to estimate the number of singular visitors, to detect the most important search engine keywords that lead to a web page, or to monitor the browsing

Your personal data collected through these cookies is processed subject to your explicit consent under the first paragraph of Article 5 of the PDPL.

Advertising and Marketing cookies are used by our business partners to profile your interests and show you relevant advertisements. Your personal data collected through these cookies is processed subject to your explicit consent under the first paragraph of Article 5 of the PDPL.

- improve service performance by enabling us to better understand visitors.
- They enable us to understand how the portal is used by visitors, help us obtain statistical data, understand general tendencies, and improve content.
- They ensure that the site you visit works and provides the necessary services.
- They are used to increase performance by improving the functioning of the site.
- They provide easier use of the site by visitors by saving the choices made by the visitor to the website.
- They allow us to measure how effective advertisements are and to present to visitors advertisements in line with their interests.

They do not cause harm to your computer and are free of viruses. They never collect, store or allow us to process your identifying data.

#### YOUR RIGHTS REGARDING YOUR PERSONAL DATA

Regarding your personal data, you are entitled to:

- 1) Learn whether or not your personal data have been processed,
- 2) Request information on the procedure in the event that Your Personal Data have been processed,
- 3) Obtain information on the purpose for which Your Personal Data have been processed, and whether or not it has been used in line with the relevant purpose,
- 4) To know the third parties to whom personal data are transferred at home and abroad,
- 5) To request the correction of Your Personal Data that may have been incompletely or inaccurately processed,
- 6) To request the deletion or destruction of personal data within the scope of the provisions set forth in Article 7 of the PDPL,
- 7) To request that the third parties to whom personal data is transferred are informed of the operations carried out pursuant to sub-paragraphs (d) and (e),
- 8) To object to the occurrence of a result which is detrimental to you as a result of analyzing your processed data exclusively through automated systems,
- 9) To request compensation for damages in the event that you incur damages as a result of the illegal processing of your personal data

electronic mail (REM), secure e-signature, mobile signature or via your electronic mail address that you conveyed to us previously and which is recorded in our systems, if any, or by means of software or an application that has been developed for the purpose of the application. Your requests will be finalized free of charge within 30 days at the latest as of the date on which they are sent to us via the specified means.

As stipulated in the "Communique on the Procedures and Principles on the Application to Data Controller" published by the Personal Data Protection Authority in the Official Gazette on 10.03.2018 and issue no. 30356, your requests in the application shall be replied to free of charge; however, if your application is replied to in writing, you are charged 1 TRY for each page over the first 10 pages, and if the reply is submitted in a storage medium such as a CD or flash/external memory drive, you are charged a fee that will not exceed the cost of such storage medium. If your application is due to our fault, the fee will be refunded to you.

Your application shall be responded to in accordance with the relevant provisions set forth in the PDPL and Silkar Madencilik may request some confirmatory information from you in order to confirm that the applicant is the data subject person. Such information may be requested only in order to identify the true data subject and to share application results with the correct person.

#### HOW TO MANAGE COOKIE PREFERENCES

You can only change your preferences on the use of cookies, or block or delete certain cookies, by changing your browser settings. In order for you to control cookies, many browsers provide you with an option to accept or reject cookies, accept only certain types of cookies, or receive warnings when the website requests storage of cookies on your device. Besides, there is an option to delete any cookies already recorded on your browser. However, if you disable or reject cookies, it may be necessary to set some preferences manually, and as we will be unable to identify your account(s) and associate it with you, some features and services on the Portal may not function smoothly. You can change your browser settings by clicking on the relevant link on the following table.
